Steven Nielsen was the president and CEO of Rocky Mountain CRC. Rocky Mountain CRC is a nonprofit 501C3 institution which provides technical expertise and permanent financing for the development and preservation of safe, clean, and affordable housing.

Steven spread his educational training throughout the state of Utah earning a Bachelor of Science (B.S.) in Accounting from Brigham Young University, and later a Juris Doctorate in Corporate, Securities, Tax, Trust and Estate Law from the University of Utah. During his career, Steven has worked as the Director of Corporate Finance for the Utah Division of Securities, Deputy Commissioner & Staff Attorney for the Utah Department of Financial Institutions, and as Presidents of both Escrow Bank, USA and Capmark Bank.

Steven elected to cap his already successful working career by accepting the position of President and CEO of Rocky Mountain CRC in December 2014. During his time with Rocky Mountain CRC Steven has been instrumental in establishing an organization that has facilitated the development and preservation of safe clean and affordable housing.

Some of his most notable accomplishments while at Rocky Mountain CRC include:

Expanding the company's operating footprint to include seven states in addition to the great state of Utah. This has helped spread the significant capital originating from the state of Utah to other western states, benefiting

tremendously the low- and moderate-income households in those areas.

Steven has been instrumental in recruiting and retaining over 35 banks to invest in Rocky Mountain CRC's mission. Under Steven's management, Rocky Mountain CRC is the steward of over \$565 million, which capital is used to finance

affordable housing in Utah, Arizona, Nevada, New Mexico, Idaho, Colorado, Wyoming, and Montana.

Most notably, during his tenure with Rocky Mountain CRC, Steven has overseen \$292+ million in financing which has contributed to the capitalization of over 7,600 affordable units.

Steven's accomplishments and contributions to the affordable housing community in Utah and surrounding states has been impactful, not just to the households he has helped finance, but he has also helped build awareness and meaningful change in the affordable housing industry. Key Note Speaker Governor Spencer Cox

Gov. Spencer J. Cox is a husband, father, farmer, recovering attorney, and Utah's 18th governor. He's also currently serving as 2023-2024

chairman of the National Governors Association.

Gov. Cox has a long track record of public service, serving as a city councilmember, mayor, county commissioner and state legislator before being appointed as Utah's lieutenant governor in 2013. He was sworn in as governor on Jan. 4, 2021.

During his first term in office, Gov. Cox has cut \$1.1 billion in taxes, implemented landmark changes in water law, water conservation and infrastructure planning, locked in record funding for education and teachers, enacted universal school choice, and secured funds for affordable housing. A long-time advocate for suicide prevention and mental health resources, he's become a national voice on protecting youth from the harms of social media. He also signed early education and workforce program funding, launched the One Utah Health Collaborative, and expanded opportunities for women, diverse As our state grows, we must provide more housing opportunities, build more trails and recreational options, and invest more in strategic infrastructure for the future of Utah

With a focus on solutions, Gov. Cox promotes respect in politics and innovation in government, works across party lines to find common ground, and regularly participates in hands-on service projects. These elements are the foundation of his NGA Chair's Initiative, "Disagree Better: Healthy Conflict for Better Policy."

A sixth-generation Utahn, Gov. Cox was born and raised in Fairview, a town of 1,200 in the center of the state. He met First Lady Abby Palmer Cox at age 16 and they married after he returned from serving a two-year mission for The Church of Jesus Christ of Latter-day Saints in Mexico. He attended Snow College, Utah State University, and the Washington and Lee University School of Law, then clerked for U.S. District Judge Ted Stewart and worked at a Salt Lake City law firm. Several years later, Gov. Cox and First Lady Cox moved back to Fairview to raise their four children – Gavin, Kaleb, Adam, and Emma Kate – on the family farm. The governor, first lady and Emma Kate currently reside in the Kearns Mansion, also known as the Governor's Mansion, in Salt Lake City.

January 16th starts the 2024 Legislative Session

The 16th may be the official start of the session, but work started to stage the session the day after last year's session closed. The Governor has already set the stage for the state budget with a large amount of funding for housing and homelessness. (Deseret News)

What to expect this session. The session will start focusing on setting the budget through appropriation committees, Housing & Homeless are in the Social Services Appropriation. We need to work on moving housing out of Social Services and back into Business, Economic Development, and Labor Appropriations Subcommittee because housing is economic development. But that is a conversation for another time.

In the beginning we will also see bills that have been vetted during the interim session on the floor. We will see bills introduced on Land Use, Property Tax, Landlord Tenant, Energy, and other items that will affect housing.

What to expect from the Utah Housing Coalition. Each week we will send out a bill tracker with bills we are following.
